You're losing 2,336 gallons a year if you don't






History of Water Restrictions

Decreased water available in the Poudre River and Horsetooth Reservoir







High Park & Hewlett Fires Soil and ash in the Poudre River

Water Supply Shortage Response Plan

Response Level 1 Started April 1

- 2 days/week watering
- No watering between
 10am 6pm
- No spraying impervious surfaces
- Special permits





Enforcement

- Goal: participation and cooperation, not citations
- Employees trained and deputized
- Responded to complaints
- Committed to an educational approach







2013 Water Restrictions

Why WATER RESTRICTIONS?

Restrictions were implemented due to water quality issues related to the 2012 forest fires and persistent drought conditions.

RESPONSE Levels

The City's Water Supply Shortage Response Plan addresses four levels of water shortage.

PERMITS

WASTING Water

In addition to water restrictions, City Code always prohibits wasting water:

- It is unlawful to waste City water in any manner.
- Water shall not run or be discharged onto the streets or sidewalks.
- Automatic sprinkler systems must be maintained.

EDUCATION is Key

Education is the first step to enforce
