All Basin Roundtable members are invited to attend the Statewide Roundtable Summit on Thursday, March 3, 2011. The meeting is an opportunity to meet your fellow cohorts from around the state and continue connecting the activities and entities within the 1177 process.

The Summit will take place at the Doubletree Hotel in Westminster, about ten miles northwest of Denver. Attendance for all roundtable members is free and the public is invited to attend for a small cost. Travel to and from the Summit will be paid for each roundtable's IBCC representatives, the Education Liaison and two additional members on an as-needed basis. PEPO has also set up a scholarship fund if other members require travel reimbursement. **Please inform your roundtable Chairperson if you require financial assistance.**

All are encouraged to attend the Summit to accomplish the following:

1. Feedback incorporated from the basin roundtables on the conceptual ideas from the IBCC's emerging framework
2. Roundtable members discuss their role in the development of IBCC recommendations and the portfolios of solutions for meeting the state's water supply needs
3. Identify approaches for involving a broader set of decision makers and the public
4. Develop greater understanding of other roundtables' approaches to exploring water supply strategies
5. The process is prepared for the next phase of implementation
